## **RESOLUTIONS**

1. At first the proposed statutes were approved unanimously.
2. The discussion takes on regarding the 1993 annual meeting. It is suggested to select at once the Club for next year 1994. Two clubs present their candidature, RC.WESTERLO (Belgium) and RC.KOLBAECK (Sweden). RC.WESTERLO indicate that they are located at the center of Europe thus facilitating arrangements. RC.KOLBAECK informs that they are able to organize the meeting in 1993 but not in 1994. RC.WESTERLO informs that they can take care of either 1993 or 1994. From this discussion it appears that it is necessary to change the proposed statutes.
3. The following modifications are decided regarding the statutes approved under paragraph 1 :

In the third paragraph the first sentence is replaced by the following :

**"EUROTARY 87" will organize yearly meeting (calendar year) for the Association members and spouses."**

Paragraph four has been given the following wording :

**"Every annual meetings will vote for time and place for the two nexts meetings. Every Rotary club reppresented will dispose of one vote. The choise of the first meeting will be definite, and the second will be an option to be confirmed. The Club selected for the first meeting will settle the date for the meeting."**

The following two paragraphs are added

**6° SEAT : the seat of the Association will be the seat of the Club selected for next year meeting.**

**7° BOARD : The President of the Club selected for next meeting will be the Chairman of the Association and he will appoint the members of the board.**

4. After these amendements of the statutes the selection of the annual meetings in 93 and 94 were decided as follows :

For 1993 RC KOLBAECK (Sweden)

For 1994 RC WESTERLO (Belgium)

RC KOLBAECK (Sweden) settles the date of the meeting to the first week-end of september 93.

The President conveys his sincere thanks to all present visitors from different countries.

The meeting is closed whereby all members of EUROTARY 87 are invited to RC KOLBAECK (Sweden) the first week-end of September 93.

### ASSOCIATION "EUROTARY 87"

#### STATUTES

1. "EUROTARY 87" is an association of the Rotary Clubs in Europe that were founded in 1987.
2. The purpose of "EUROTARY 87" is to establish ties of friendship between Rotarian from all regions in Europe thereby contributing to better understanding between the countries.
3. "EUROTARY 87" will organize yearly meetings (calendar year) for the Association members and spouses. Accommodation will be arranged as far as possible in Rotarians homes. Travel expenses will be paid by each visitors who will also contribute to general expenses with an amount paid in advance.
4. Every annual meeting will vote for time and place for the two nexts meetings. Every Rotary club represented will dispose of one vote. The choise of the first meeting will be definite, and the second will be an option to be confirmed. The Club selected for the first meeting will settle the date for the meeting.
5. "EUROTARY 87" will encourage other initiatives such as individual tourist trip with accomodation at Rotarians, exchange of youth, exchange of summer houses, etc...
6. SEAT : The seat of the Association will be the seat of the Club selected for next year meeting.
7. BOARD : The President of the Club selected for next meeting will be the Chairman of the Association and he will appoint the members of the board.
